 - e. DA Form 705 (Army Physical Fitness Test Score Card) with most current test not older than 6 months. (Include DA 3349 if precluded from standard 3 event test.)
 - f. Letter of recommendation from your Unit Commander.
 - g. Negative pregnancy test results, if applicable.
 - h. Certified Height/Weight or DA 5500R/DA 5501R not older than 30 days from the close date of this announcement.
 - i. Current Personnel Qualification Report Part B (PQRB).
 - j. Retirement Point Accounting Management (RPAM).

Post NTC Range Clean-up Crew

Length of FTNGD Tour:

-- 1 to 2 month tour, pending ADOS packet submission, budget and individual performance with ability to extend.

Requirements:

- Ability to lift 40+LBS
- Must be willing and able to work outside in hot, dusty, dry conditions
- Must be able to travel daily to the OCTC
- The ability to apply common sense and understanding to carry out oral instructions
- Detail oriented

*Licensed on military vehicles and equipment is not required but beneficial

Duties:

- The Post NTC Range Clean-up Crew will thoroughly police call rifle/pistol and gunnery ranges used prior to the 116th CBCT's NTC rotation. The crew will pick up and remove all remaining brass, metals, and debris on the ranges.
- The crew will establish work site areas for brass and trash collection.
- The crew will load and unload recyclables, trash, equipment and supplies.
- The crew will separate the recyclables from the landfill substances.
- The crew will perform general laborer tasks associated with range operations and maintenance.
- When required and if appropriately licensed, crew members will drive military or GSA vehicles.
- The crew leadership will coordinate with OCTC Range Officer and the Recycling Center Manager on daily tasks.
- Other duties as assigned.
